This is an attachment and written request for penalty abatement as enforced by Section 6652 of the Internal Revenue Code as Outreach, Inc. (EIN 20-0636360) is knowingly filing its annual report past the organization's extended due date of November 15, 2013.

Reasonable cause can be demonstrated by the organization for failing to timely file its return by its extended due date. While the organization has a mailing address within the United States, the organization exclusively serves its health and welfare mission outside of the United States in East Africa.

The organization has always exercised due care while practicing financial transparency as goodwill ambassadors of the United States but cultural (tribal) traditions, foreign bartering (monetary) transactions and global logistics force the organization to face unforeseen hardships due to the nature and extent of the organization's mission and purpose.

Because it has always been difficult to logistically coordinate the organization's activities and regulatory reporting requirements with the Internal Revenue Service, the organization is considering moving to a fiscal year rather than a calendar year in order to better manage both reporting regulations and charitable service cycles.

Please abate the late filing penalty for our organization.
